## THE THEMES OF CONFERENCE

This is an **international conference** that examines recent developments and prospects for the evolution of comparative law and international law. Within the framework of the Conference will be presented **scientific papers in all areas of legal sciences**, which will be scored according to their content in one of three sections.
